

ID201 INDUSTRIAL DESIGN I

Syllabus for 2022-23 Fall Semester

The goal of this course is to introduce the students with the formal, structural and functional components of product design. Students are encouraged to consider issues of manufacturing and use, such as efficiency, use of materials, and effective use of resources. Basics of user factors in the context of industrial design, such as physical and cognitive ergonomics, product language and ease of use are addressed as a part of user-centred design methodology, which is integrated in introductory level product design projects. Upon successful completion of this course, you will:

- Explain the relationship between structural properties of materials and functional aspects of products.
- Examine designed objects in terms of their structural complexity, functionality, efficiency in manufacturability and use of resources.
- Predict the impact of the physical and cognitive affordances of products on human-product interaction.
- Relate form and function of product with users' experience with them.
- Use appropriate user testing methods at necessary steps throughout the design process at a basic level.
- Create prototypes to communicate and gain feedback on design features.

GRADING

Briefs for each project will be provided separately. Changes in distribution of grades for each project may occur – you will be informed about them.

- Project 1 (10%); Project 2 (50%); Project 3 (40%)

3D MODELLING ASSIGNMENTS

Throughout the semester you will be given 3D modelling assignments improve your design communication skills. These submissions will be not be graded. However, we strongly encourage you to complete all of them for the opportunity to get our support; because from now on 3D modelling is expected in studio projects by default (and there are no more communication courses).
