# Course Description

Minimum 20 consecutive working days of summer practice in a manufacturing or a service system. Systems analysis. Identification and formulation of an industrial engineering problem.

Pre-requisites: IE 399

This course aims to equip the students with professional experience in an industrial/business setting with a critical perspective.

- 1. Identify and define an industrial engineering problem in a real life environment and design a viable methodology for its solution

- 4. Demonstrate effective communication skills
- 5. Recognize the need for, and have an ability to engage in life-long learning

(Oral presentations will be scheduled in groups. In order to get full marks from oral presentation it is required to attend and participate in all presentations within the respective session.)

### *Grading:*

Students who receive at least a score of 3 from each of Questions 1.a, 1.b, and 1.c of Student Evaluation by Company Supervisor (SE) complete their summer training successfully. Students who fail to do so are considered as "Unsuccessful by SE" and receive F letter grade at the end of the semester. Such students are not required to submit a report or make oral presentations. Students who are "Successful by SE" are eligible to submit their summer training report and make an oral presentation of their summer training experience.

### Final Grade:

The grade for a student will be set based on the evaluation of IE399 Summer Training Report (STR) and Oral Presentation (OP). STR and OP are marked out of 100 according to the pre-specified guidelines. 80% of the STR grade and 20% of the OP grade constitute the total grade. STR of each student will also be evaluated based on its format and style. A student who fails to receive at least 3 points from the format and style rubric (https://ie.tedu.edu.tr/ie-summer-practice-assessment-guideline) are considered as "Unsuccessful by Format and Style of the Report (FSR)" and receives F letter grade regardless of the grade that s/he receives from STR and OP.

Students who are Unsuccessful by SE or FSR receive F letter grade. The following rubric applies to all "Successful" students:
